BEDB - Agenda

The Board of Trustees supports having a planned agenda which keeps the public advised of Board business and allows the Board to address its priorities and items of importance as they arise.

The order of business set forth in the meeting agenda may be changed by general consent or majority vote of the members present. Requests for reordering or revising the agenda should be directed to the Chair and be considered at the beginning of the meeting.

In the interest of time, certain housekeeping agenda items may be organized as one agenda item: Consent Agenda. Generally, these items have been reviewed by Board members through documentation received prior to the meeting and require no discussion. At the beginning of the meeting, the Board Chair will make suggestions of Board consent agenda items to be addressed with one motion. Board members have the option of accepting or rejecting the agenda items for the consent agenda.

Only items receiving a unanimous vote may be on the Consent Agenda.

Suggested agenda items must be submitted to the Dean and the Chairman of the Board at least fourteen (14) calendar days prior to a meeting. The Dean and the Chairman will decide what items are included on the agenda. Each board meeting agenda will include Next Agenda, where board members can offer topics for consideration. Board members will receive the agenda with supporting materials prior to the meeting.

In accordance with RSA 91-A:2, meeting notice shall be posted in at least two (2) places, warning each Board meeting at least 24 hours in advance. The Founders Academy Public Charter School will post its meetings on the school's website and in a publicly accessible place in the charter school.

Dean of School's Report March 22, 2017

- 1. Admissions: Placement exams are on March 11 and 18. To date, there are 153 applications in process. Completed and accepted are as follows: 75 in 6th grade, 20 in 7th grade, 9 in 8th grade, 9 in 9th grade, and 4 in 10th grade [35 additional applications are missing paperwork]. A total of 118 accepted and completed at this time.
- 2. **Teacher Code of Excellence:** The teachers at Founders have established a Teacher Code of Excellence which consists of accountability, inspiration, leadership, self-improvement, integrity, respect, professionalism, communication, support, and fulfillment.
- 3. Teacher Agreements and Hires: Teacher agreements for 2017-2018 are scheduled to go out in late March. One teacher, to date, has notified she will not return. The job fair brought 23 individuals. Interviews are ongoing for teachers in science, math, English, world language, chorus (part-time), and business (part-time), as well as a Director of Faculty and an Assistant Director of Guidance.
- **4. Scheduling (update):** The schedule is being finalized for the 2017-2018 school year.
- **5. Teacher Assessments (update):** One on one meetings are in progress and very productive. In addition to listening to teachers, there is a review of syllabi, web pages, portals and IEP/504 sheets.
- **6. New Hampshire Educational Theatre Guild:** The Drama Club put on "Little Women" at the New Hampshire Educational Theatre Guild Festival on March 11 at Newfound Regional High School. The club was selected as a top show and will advance to the State Festival on April 7 and 8.
- 7. Concert: The Spring Concert (chorus and band) was postponed due to weather. On March 20 at 6pm the Chorus Concert will occur. On March 21 at 7pm the Band Concert will occur. Both concerts will take place in the lower cafeteria.
- **8. Best Practices 2017:** Best Practices took place on March 17. Over 250+ personnel from charter schools across New Hampshire enjoyed 40 seminar sessions and guest speakers.
- **9. Spring Fling 2017:** Spring Fling 2017 is planned for May 6 from 10-2pm. Round Tables are working on booths. Volunteers are needed.
- **10.** Field Day 2017: Field Day is planned for May 26, 2017.
- 11. **Teacher of the Month:** The February Teacher of the Month is Mr. Tellier.
- **12. Volunteers of the Month:** The February Volunteers of the month will be announced soon.

4) Dean's Report: Dean Mooney started her report by saying that the High school Information Night went well and had not heard any complaints until 10 minutes ago.

Admissions: To date, there are 160 applications in progress for next year. The deadline for applications was January 30, 2017.

Required Placement Exams will take place on March 11 and 18.

- **1. Honor Roll:** The second quarter ended on January 20. The following percentages of students made the honor roll: 16.5% made High Honor Roll (A or greater i.e., 94% or higher); 37.2% made Honor Roll (B+through A-i.e., 87-93%); 12.3% made Honorable Mention (B i.e., 84-86%).
- **2. Teacher Assessments:** The third segment of teacher assessments 2017 is one on one meetings with the Dean. Template forms have been distributed to teachers for these meetings. The timeframe for the meetings is in March.

- 7. Smarter Balanced Test: The testing window for 2017 is: March 14 June 9, 2017. The test is for grades 6, 7 and 8. The Smarter Balanced Subcommittee is coordinating and scheduling the testing.
- 8. Website Maintenance: An independent contractor is now helping with regular website maintenance and updates.
