- i. Bob Best: Attorney, supporter of charter schools and school choice for long time, and of Founders for couple of years. Greatly admires Founders' mission and focus on history and great people in history.
  - 1. Mrs. Lavallee question: what areas would you be interested in joining? Answer: wherever the need is.
- ii. Barbara Comtois: Corporate Accountant, homeschooled two children, advocate for charter schools and school choice.
   Appreciates Founders basing curriculum on classics and looking to history.
  - 1. Mrs. Lavallee question: what areas would you be interested in joining? Answer: wherever the need is.
- b. Review Parent Steering Committee Board Member candidates
  - i. Sue Lawton Solutions Engineering Project Manager, good experience in communication. Public school was not an option for our son; we heard about Founders and it just felt right. We heard rumors of issues last fall and want to take a more active role in the school community. The overwhelming majority of families are happy here, and I want their voices to be heard; I want them to be part of this community and this dialogue.
    - 1. Mrs. Lavallee question: What is your approach to problem resolution? Answer: Listening is vital, as well as making sure you have all the facts.
  - ii. Jon DiPietro Father of two students here; this school singlehandedly pulled 11th grader out of the academic drain. Mission of school is a dream for me and everything I want for my kids. I am a digital marketer now, but was in automation engineering for a while. This is why I tend to fix problems, to focus on what's wrong and what can be improved. I want to help the school succeed, and have the drive and the experience to do so.
    - 1. Mrs. Humphrey question: What are problems you see?
      Answer: A serious problem is all the tension here that's been around for a while. I think trust needs to be established over time and in various directions. The biggest school issue is the math curriculum.
  - iii. Kristi Ouellette: This school was answer to everything we were looking for; our student can go at her own pace here. We like being involved and active in things we care about, and this school is one of them. I received my Bachelors in education and was the admin of early childhood program, so I have experience dealing with parents and teachers, who are happy and unhappy. I also worked for NH as a child care licensing specialist, so I'm good with difficult situations. I owned a company specializing in professional development for teachers. Now I own my own travel company. Like Mrs. Lawton, we've had some issues over the years, but the door

has always been open to deal with them, teachers and administration, everyone welcomes open conversations.

- Mrs. Lavallee question: With your background in professional development, would you want be involved in a committee with Professional Development and offer workshops etc? Answer: Yes definitely, I still love doing that kind of thing.
- iv. Moira Ryan: Has worked for fortune 500 companies and has 5 degrees, including Masters in business administration and education, and is a registered nurse. I am also an educational advocate for students with learning disabilities. I volunteer at the school every day, and see what goes on, and I want to help make it a positive environment.
  - 1. Mrs. Lavallee question: What would be the first areas you would want to get involved in? Answer: Finance committee, but also curriculum.

  - 1. Mrs. Lavallee He brings problem solving skills with his engineering background, and that is something that would be very beneficial to the Board right now.
- vi. Kristy Ouellette:
  - 1. Mrs. Humphrey Same as for Mrs. Lawton, thank you for giving us so much of your time and talent, thank you for what you contribute to the school and for your skill set.
- vii. Moira Ryan:
  - 1. Mrs. Scarpone She knows a lot, which would be helpful.
  - 2. Mrs. Humphrey: She is very devoted to her student and helpful to school on daily basis.

      - ii. All in favor, none opposed, motion passes.
  - 6. Mrs. Scarpone <u>motions</u> to vote for Moira Ryan for a one year term. No second.

  - ii. To date there are 132 applications in process. The 100 received applications are as follows: 74 in the 6th grade, 18 in 7th grade, 5 in

the 8th grade, 2 in 9th grade, 0 in 10th grade, 1 in 11th grade and 0 in 12th grade. A total of 71 completed applications at this time.
