 - O To date there are 170 applications in process. The 143 received applications are as follows: 87 in the 6th grade, 25 in 7th grade, 10 in the 8th grade, 11 in 9th grade, 8 in 10th grade, 2 in 11th grade and 0 in 12th grade. A total of 116 completed applications at this time.

 - Sue Lawton-we should have a plan where students can fundraise so the students with a strong interest in science who want to go can start planning for it.
 - Mrs. Lavallee thanked Ms. Scantlebury for the hard work in preparing her presentation and offer to donate her services to teach the class in year one. She also thanked her for providing lunch to every employee at the last PD day from her company stoneandfirepizza.com.
- PTSA report-Susan Lawton presenting
 - School dances: huge thank you to dance committee first of all, the work they do is tremendous.

- We've been hearing requests from parents and students who think we should have separate middle school and high school dances. This will required additional parent involvement, especially for middle school, b/c Mrs. DiPietro can't be expected to volunteer for twice the amount of dances. Some middle school parents don't see the issue yet, but I think there is enough we've heard from that we could propose this. The high school feedback is fairly strong to begin separating some school events.
- Liam Childers: high schoolers do think that there isn't enough that distinguishes them from the middle school; this would be a way to give them their own space.
- Patty Humphrey: students should have the most say in these social things that are for their benefit.
- Matt Mercier the proposal to have there be separate dances for high school and middle school will go to the student senate.
- Dean Mooney asked for a middle school dance proposal. She receives these proposals from the dance committee currently and thinks this works well.
